Architecture & Operational Model

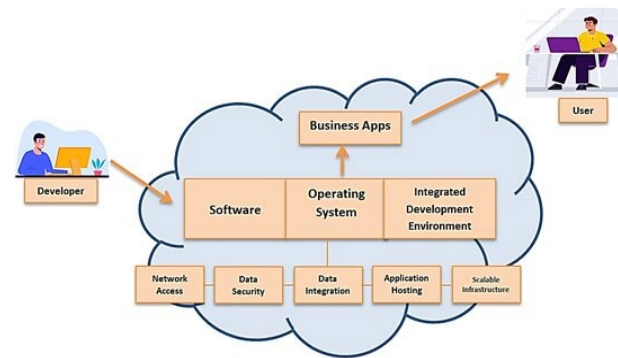

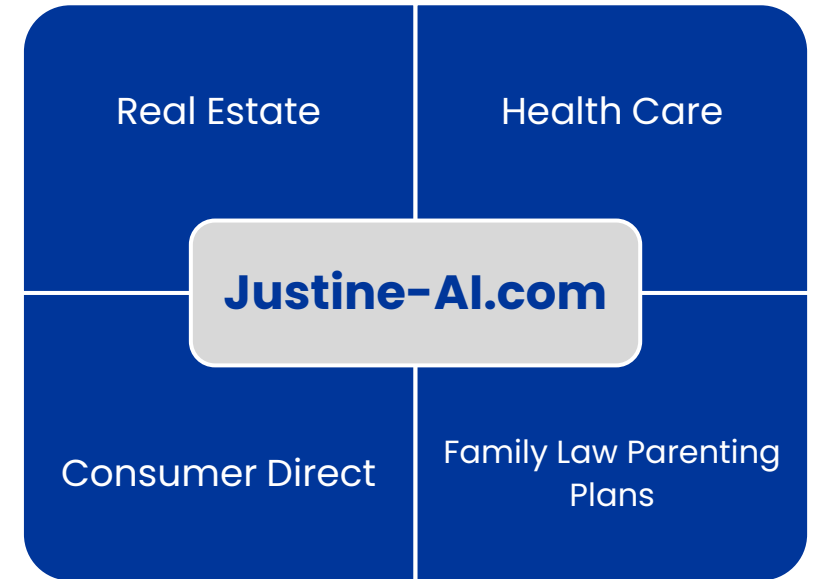
Consumer Direct, B2C & Verticals
